New titles need to be gotten to Rosemary.

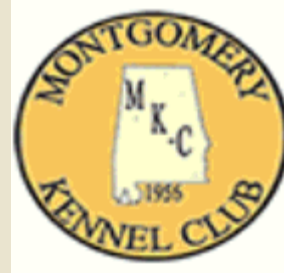

Minutes – September 21, 2011 meeting

The meeting was held at Goodwyn Community Center and called to order by Kaye Stevenson, President, at 7:15 pm. There were 29 members and 2 guests in attendance.

Kaye welcomed our guests, Joan and Alan Hackel (Borzoi).

Note – those guests having attended two or more meetings after receipt of membership application are eligible for membership upon a vote by the board – comments on any prospective member should be addressed to a board member as soon as possible.).

President's Report: Kaye announced that the Tuscaloosa Kennel Club is pulling out of our November, 2012 show. After a discussion about the options available for next year's shows, Frank moved that MKC do two shows in April with Cahaba Valley having the third day. Milly seconded the motion and the motion passed by a show of hands.

Kaye advised the members that back-to-back shows (Friday and Saturday) in April will require a lot of volunteers to work, not only on the weekend, but for the also for the Thursday set up and Friday show.

Kaye also announced that if we are going to do obedience in April we need an Obedience Chair.

Secretary's Report: Frank moved approval of the minutes of the August meeting. Milly seconded the motion. The minutes were approved.

Treasurer's Report: Mike Frakes gave the treasurer's report:

Announcements: Rea gave an update on the Bark in the Park. The focus this year will be on interactive activities such as fly ball, disc dog, etc. There will be a microchip clinic, vendors, educational information, a demonstration by a law enforcement officer and his dog, Meet the Breed, and many other activities. Admission is \$5.00 (let them know at the gate if you are working and you will not be charged the admission fee). Everyone is encouraged to come out and support the shelter.

Hospitality Committee: Volunteers needed to bring refreshments for October meeting. Frank, Corrine and Genie volunteered.

Milly announced that reservations have been made at Sinclair's East (on Vaughn Road) for Wednesday, December 14, 2011 for our Christmas Dinner.

Trophy Committee: Dave thanked everyone who brought in trophies and awards for the show. If anyone has not yet turned in their trophies, please make sure to get them to Dave and Ellen no later than the October 19 meeting.

Raffle Committee: George announced that he had received the first basket for the raffle. George tasked Corrine (MKC Volunteer Coordinator) with finding two volunteers to help with the raffle.
