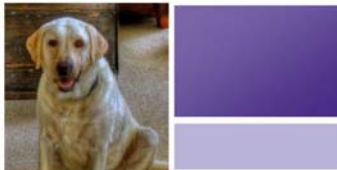


## PET LUMINARIA
